Money was raised from private donors and groups like churches and student clubs.

Volunteer Trips: Teams of volunteers traveled to Uganda in 2012 to visit the locations of water resources our organization has funded. While in those locations, our teams documented the work that was done, worked with community leaders to identify growth and development opportunities and strategies for their communities, building relationships with local residents.
